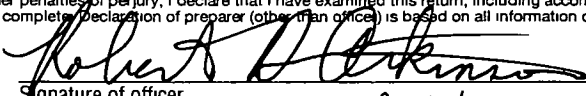

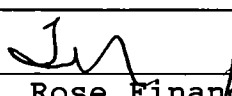

In it's first year, ITIF published over 14 reports on issues related to U.S. economic competitiveness, including high-skilled immigration, the research and experimentation tax credit, and offshoring of service sector jobs; e-government and opposition to e-commerce, including radio frequency identification device, biometrics, the practice on online law, and online sales of contact lens; and broadband telecommunications, including benchmarking U.S. broadband deployment, and articulating a "third-way" solution on the issue of network neutrality. It also released its report, the 2007 State New Economy Index: Benchmarking Economic Transformation in the States, including a version in conjunction with the National Governors' Association.

In addition, ITIF's work was published in a number of widely circulated journals and magazines devoted to these and related issues. ITIF staff also made numerous presentations at conferences around the nation on these and related topics.
